We're governed by a Board of Trustees, who work alongside our staff team, to run an active Students' Union. The UWSU has gone through continual development over the past number of years. It's an exciting and also challenging time for us, with the delivery of our strategic plan, looking at improving our governance and democratic structures and ensuring our structures are meeting the needs of our students.

This is a great opportunity to take on an essential role in a developing a dynamic charity committed to changing lives and we look forward to your application.

With Full-Time Student Officers, a professional staff team, the UWSU aims to provide essential support and services to all our students across the institutions and various campuses.

The UWSU delivers a range of services and support for its members, from independent academic advice to supporting our Course Reps to enhance their course, to enhancing the Student Experience of students through our student societies, Health & Wellbeing services and activities programmes.

The Students' Union has a vibrant Bar & Café facility at our Walsall Campus where events and activities and services come to support our student community.

### The Opportunity

As with all charities, the UWSU needs to be overseen by a Board of Trustees. This Board brings together our elected Full-Time Officers (Sabbatical Trustees) with Student Trustees, External Trustees, and a University nominated Trustee to oversee our Governance and Strategy.

This is an opportunity to become an active participant in the 4 meetings of the Board that will take place each year, as well as being on hand to take decisions between meetings when the need arises. There is also the opportunity for some Trustees to sit on UWSU Sub-Committees.

The Board of Trustees reviews the Finances of the Union, receives updates from the sub-committees, and discusses and makes executive decisions on any matters that have arisen. The hope is that the Trustee Board will be forward thinking, and support the development of the UWSU.

### The Board of Trustees

The Board of Trustees is the highest decision making body in the organisation, ultimately responsible for the work of the UWSU with particular responsibility for its financial well-being, strategic direction and legal compliance. You would sit as a Student Trustee and together with the Sabbatical Trustees and External Trustees and University nominated Trustee would comprise the Membership of the Board. The UWSU Chief Executive Officer who acts as first point of contact for the UWSU shall be in attendance and other Senior Management staff as required.

It is of great value to the UWSU to bring in individuals with the expertise we need. Part of this role will be to ensure compliance and good governance as a charity, but also to work with the Chief Executive Officer to monitor progress towards achieving the UWSU strategic plan, whilst continuing to look for new opportunities that the Union could benefit from.

### Who Are We Looking For?

The individuals appointed as Trustees will need to be sympathetic to the aims of the organisation and more generally share a commitment to the broader values of the student movement: student representation, student rights and the student experience and the importance of students having a platform to organise together to help make these values a reality.

The role requires a careful balance: Trustees need to respect the democratic will of the membership where possible but also be willing to think creatively and point out potential risk in any proposals. An eye for detail to ensure the UWSU is being well governed and the ability to see future opportunities are also important.

### **Commitment Required**

### **Attendance**

The key requirement is being willing and able to attend and contribute to the meetings of the Board. The Board will have 4 scheduled meetings each year, with other meetings added if required. Board members may also be invited to consider sitting on committees that have been delegated authority by the Board in different areas. Board members will also need to be available to approve decisions via email between meetings as required. Each meeting will have some reading and preparation work to do beforehand.

### **Term of Office**

We are recruiting 1 Student Trustee to begin serving on the Board in the academic year 2018/19. The length of time a Student Trustee typically serves is 2 years or shorter if they stop being a student during this time (i.e. graduate).

### **Training**

We utilise the support that is available from the National Union of Students (NUS) and the Charities Commission to ensure all Trustees are fully informed of the responsibilities associated with being a Charity Trustee.

#### **Wider Involvement**

Where Trustees wish to take a wider interest in what is going on within the Students' Union in addition to their formal duties as a Trustee we will welcome this. We aim to send the news of what is going on in each area of our activity to Trustees on a regular basis.

### **Trustee Role Description**

#### **Tenure**

2 years (as long as you remain a student)

### **Role Purpose**

The Trustees are ultimately responsible, individually and collectively, for all activity within The University of Wolverhampton Students' Union (UWSU). The Trustee Board is responsible for setting the vision and values of the organisation and for ensuring the delivery of organisational purpose. The Trustees ensure development of and agree a long-term strategy. They approve and monitor plans to deliver the strategy.

### **Key Responsibilities**

#### **All Trustees**

Trustees are accountable for delivering the responsibilities detailed in the UWSU Memorandum and Articles of Association and supporting documents. Notwithstanding this all Trustees have a duty to:

- Ensure that the UWSU acts in accordance with its charitable objects, articles of association and other guiding documents and in particular remains true to its mission, vision and values.
- Facilitate the UWSU being a student-led organisation
- Help the UWSU achieve its objectives and improve the lives of its members
- Ensure that the UWSU complies with all relevant legislation and regulations, including relevant charity acts and education acts
- Ensure that the UWSU does not undertake activities that put its financial stability, members or reputation at undue risk
- Work with other Trustees, staff and volunteers in a constructive manner and forthe greater good of the UWSU
- Participate fully in Board of Trustees meetings and join one of the Trustee Board's Committees if required
- Use their personal skills and experience to ensure the UWSU is well run and efficient
- Seek external professional advice where there may be material risk to the UWSU or where the Trustees may be in breach of their duties or at any other appropriate moment
- Add value to the Trustee Board and the UWSU through generating ideas, challenging the status quo, broadening thinking and supporting and promoting innovation and creativity
- Abide by the UWSU Trustee Code of Conduct

#### Student Trustees and Sabbatical Trustees

Student Trustees and Sabbatical Trustees have a particular responsibility to:

- Ensure decisions of the Board of Trustees and its Committees take account of the needs and views of the UWSU members
- Ensure the UWSU considers the needs and views of all student groups including as examples Postgraduate, International and part-time students
- Ensure effective communication between the UWSU and its members

### **External Trustees & University Nominated Trustees**

External Trustees have a particular responsibility to:

- Use their particular knowledge, skills and experience to improve the decision making of the Board of Trustees and its Committees
- Support and empower the Student and Sabbatical Trustees to act as student leaders for the UWSU
- Act as mentors, as required, for new or less experienced Trustees

#### **Expectations, Trustees should be:**

- Committed to the purpose, charity objects and values of UWSU
- Committed to facilitating student leadership both within and through the Trustee Board and through the wider democratic structures of UWSU
- Constructive about other Trustees' opinions in discussions and in response to staffmembers' contributions at meetings
- Able to act reasonably and responsibly when undertaking Trustee Board responsibilities
- Able to maintain strict confidentiality
- Understand the importance and purpose of Trustee Board and Committee meetings and be committed to preparing for them adequately and attending them regularly
- Able to analyse information and when necessary challenge constructively
- Able to make collective decisions and stand by them
- Able to respect boundaries between management and governance functions
- Excellent role models who promote the highest standards of probity and integrity
- Firm supporters of equality of opportunity and committed to promoting diversity

### Eligibility

All appointed and elected Trustees are required to sign a Trustee Declaration Form.

To be eligible to be a Trustee and by applying for this role you declare that you:

- Are willing to act as a Trustee of Wolverhampton Students' Union, which is a registered charity (charity number 1136470) and a company limited by guarantee registered in England and Wales (company number 07275807).
- Understand your organisation's purposes (objects) and rules set out in its governing document
- Are not prevented from acting as a Trustee because you:
  - have an unspent conviction for an offence involving dishonesty or deception
  - are currently declared bankrupt (or subject to bankruptcy restrictions or an interim order)
  - have an individual voluntary arrangement (IVA) to pay off debts with creditors
  - are disqualified from being a company director
  - are subject to an order made under section 429(2) of the Insolvency Act 1986
  - have previously been removed as a Trustee due to misconduct or mismanagement
- are disqualified from being a Trustee by an order of the Charity Commission under section 181A of the Charities Act 2011
